***REGULAR MEMBERS** – Must attend at least two monthly Club general meetings (introduction at the first, and the membership votes at the second meeting). Regular members may provide input at monthly general meetings; vote on Club business; use the arena at any time (if not rented); have the arena fee waived at Club events; rent the arena and/or club house at discounted rates; serve as a Board member to help provide direction for the club, and/or serve on a committee (if desired). Junior members do not have voting powers and cannot hold a Board position. Regular members are expected to participate in at least one Club event in some manner (Jr. Rodeo, barrel races, Lucky 7 gymkhanas/poker trail rides/obstacle courses, Quadzilla quad races, bbq dinners, Fall Festival, etc.), and at least one work day each year to help maintain the grounds. There is a free member appreciation dinner in December.

****ASSOCIATE MEMBERS** – Do not need to attend any monthly general meetings (but may, if desired), do not have voting powers, and cannot hold a Board or committee position. Arena fees are waived at events produced by Clements Buckaroos (barrel races, Lucky 7, etc.).

ALL MEMBERS (Regular and Associate) agree to abide by the rules set out in the By-Laws (Regular members) or Guidelines (Associate members). These rules are given at time of joining, and are subject to modification as needed.

Annual dues are due **February 1** of each year. A reinstatement fee of \$25 will be charged for dues paid after March 1. Every member of this Club shall have equal right to the benefits and privileges of this Club as defined by their membership category and in the organization's By-Laws.
